The regular meeting of Mayor and Council of the Borough of Buena was held May 27, 2025 commencing at 6:31 P.M. at the Borough Hall with Mayor Baruffi presiding. Mayor Baruffi announced that this meeting was being held in compliance with the Open Public Meetings Act and notices of this meeting have been provided, via email, to the Press of Atlantic City and the Daily Journal on November 9, 2024 as well as being posted on the bulletin board in Borough Hall.

MAYOR'S REPORT: First order of business.

Mayor Baruffi announced the first portion of the meeting would be dedicated to honoring and memorializing Angelo M. Capizola, First Chief of Police for Buena Borough. Mayor Baruffi introduced Chief Capizola's sons Peter, Joe, and Dave Capizola and other family members who were in attendance. Mayor Baruffi shared that he graduated high school with Peter and highlighted the friendship they have maintained over the years. Mayor Baruffi remarked that Dave had not only been his former teacher but also guided him through his student teaching experience at Milanesi School. Mayor Baruffi shared that Joe had taught him everything he knows about government and politics, and even helped him secure his first teaching position at Cleary School and hired him as a counselor in 1989. Mayor Baruffi thanked Joe for all he has done for him. Mayor Baruffi individually recognized other family members in attendance, including those who were unable to attend.

#### Mayor Baruffi read the following speech:

Tonight, we're here not only to remember, but to celebrate a man whose life was defined by service, commitment, and love for his community-Mr. Angelo M. Capizola.

Angelo was born and raised right here in Buena Borough, and he remained a devoted lifelong resident of the community he so faithfully served. His roots ran deep, and his contributions touched nearly every corner of our town.

For 25 years, Angelo owned and operated the Ideal Maid Bakery, a local institution that did far more than provide bread and sweets. It was a gathering place, a symbol of small-town spirit, and a source of sustenance for generations of families in Buena.

But his service to our town extended far beyond his business. Angelo answered the call to public service at a young age, joining the Landisville Volunteer Fire Department in 1937. He also served as a volunteer Special Police Officer, demonstrating early on the kind of character that would define his life.

In 1947, he took a historic step for Buena by organizing and leading the formation of our very first official Police Department. As our inaugural Chief of Police, he served honorably from 1949 until 1962. He later continued that service as Director of Public Safety from 1967 to 1971, always putting the safety and well-being of our citizens first.

In 1996, Angelo's lifetime of dedication was formally recognized when he was named Buena Borough/Buena Vista Citizen of the Year—an honor that only begins to reflect the lasting impact he made on this community. And now, we reach a very special moment in tonight's ceremony.

In recognition of his legacy, his service, and his enduring place in the heart of Buena, we are proud to unveil a portrait that will forever remind future generations of Angelo M. Capizola's remarkable life. This portrait is more than an image—it is a symbol of gratitude, remembrance, and the spirit of a man who gave so much to so many.

As this portrait is revealed, let it serve as a lasting tribute to a life well lived, and a constant reminder to us all of the values Angelo stood for: community, dedication, integrity, and heart.

Let us all take a moment to reflect on the legacy of this extraordinary man, and let this portrait inspire us to carry forward his example in our own lives.

And so, as Mayor of the Borough of Buena, it is my great honor and privilege, on behalf of the entire governing body, to officially recognize and express our heartfelt gratitude to Angelo M. Capizola. He was, and always will be, an invaluable member of our community.

## Thank you, Angelo. You will never be forgotten.

Mayor Baruffi called Peter, Joe and Dave to the front of the meeting room to join him in unveiling the portrait of their father. The Capizola brothers expressed their heartfelt thanks to Mayor Baruffi and Council for memorializing their father. They shared how proud their father was to serve Buena Borough.

## Mayor's Report Continued:

- Mayor Baruffi read into record an email received from Sandra Opoku, NJDOT providing an update on the Route 40 project which includes Route 40, CR 557 (Tuckahoe Road) to Route 54 Blue Anchor Road/Wheat Road (CR 615). Mayor Baruffi informed those in attendance that the design is being finalized with verification through pipe video inspection. The state requested the Borough's written permission for their subcontractor to perform Mobile Dredging and Video Pipe Services to perform video inspections of the existing drainage pipes along S. Central Ave. and Kimberly Lane. Mayor Baruffi confirmed that he approved the inspections.
- Mayor Baruffi informed Council and those present that a full-time laborer position has been posted on the Borough's website. He noted that Road Supervisor Nimohay and Administrator Coraluzzo are collecting applications. Interviews are expected to be conducted in mid-June.
- Mayor Baruffi reported that the Memorial Day Services at the American Legion Post 270 were a success with over 100 in attendance.

## **COMMITTEE REPORTS:**

## PLANNING/ZONING/INSPECTIONS

#### Mayor Baruffi reported the following on behalf of Councilman Giovinazzi:

- A court date is pending for 104 & 106 South Franklin Street and inspections are scheduled for this week. The property owner will follow up with the permit office once all necessary repairs have been completed for items that did not pass inspection.
- 103 & 105 Marlyn Ave are scheduled to appear in court on June 5 for failing to comply with a notice to remove chickens from a residential lot.
- Zoning Officer Keenan spoke with the property owner of 407 SW Blvd. regarding a notice of violation for business use and outdoor storage in a residential zone. The tenant/business will vacate the property in August.

#### FINANCE/TAX COLLECTOR/ASSESSOR

Councilman Alvarez provided a breakdown of the current budget, detailing the allocation of funds as follows: a percentage designated for supplies, a portion for professional services, and a share allocated to interlocal agreements. Councilman Alvarez reported to date, the tax collection total is \$1.582 million, of which \$5,900 is attributed to collections from the 2024 tax year.

## PUBLIC SAFETY/STREET LIGHTS

Public Safety Director Adams reported the following for the month of April 2025:

- Shore Animal Control responded to 28 calls.
- EMS Calls: Buena Borough 56, Buena Vista Township 12, Vineland 5, 6 calls for transportation.
- Franklin Township Police Department reported 1014 calls for Buena Borough.
- The Officer of the Month for April 2025 is Officer Thomas Rambone of Franklin Township Police Department. Officer Rambone is a veteran officer assigned to the Patrol Division. He is also a department firearms instructor in the Training Unit.

#### RECREATION

- Councilwoman Barsuglia reported that the Easter Bunny Breakfast event generated a profit of \$930.00.
- Councilwoman Barsuglia informed those present that the Recreation Commission's Community Yard Sale will take place June 7 and 8 from 8 a.m. to 1 p.m. If residents wish to register as a yard sale participant, they may email <u>buenarec@gmail.com</u>.
- Councilwoman Barsuglia stated that the Brick Fundraiser is open until June 6. Purchase forms may be obtained by emailing <u>buenarec@gmail.com</u> or in-person at the Borough Clerk's office.
- Additional information is forthcoming regarding the Arts in the Park program. They received a \$7400.00 block grant from the Atlantic County Heritage and Cultural Society.
- Bands have begun registering for the Concert in the Park series. Once all submissions have been received, the performance dates will be announced. The first concert is scheduled for June 28.
- The Special Events Committee met to discuss events for Buena Day.
- Councilwoman Barsuglia read into record a press release regarding Received notice regarding a grant applied for through Sustainable New Jersey for safe streets and technical assistance. The press release explained that the complete streets policy will be updated through South Jersey Transportation and Planning Organization (SJTPO) Complete Streets and Technical Assistance Program. Councilwoman Barsuglia noted that the Borough is one of three municipalities to be selected to receive expert support in enhancing its transportation policy.

# BLDGS/GROUNDS/IMPROVEMENTS

- Councilwoman Andaloro reported that the air conditioning units in all municipal buildings are currently being inspected for routine maintenance and the irrigation systems are being turned on.
- Within the next two weeks, flowers will be planted at Borough Hall and at the Joe Dale Pavillion.
- Councilwoman Andaloro proposed establishing a committee to design welcome signs reading "Welcome to Buena Borough" to be displayed at the entrances to the town. She also suggested placing a sign reading "Welcome to Bruno Melini Park" at the entrance of the park.
- Councilwoman Andaloro stated that uncut grass notices are consistently sent to the same residents each year, noting the increasing cost to the Borough for ongoing maintenance and enforcement. She deferred to Road Supervisor Nimohay to provide an update regarding the notices. Mr. Nimohay explained that 33 notices have been sent. Discussion ensued regarding amending the ordinance to increase the fees for grass cutting.

# ROADS/RECYCLING

# Councilman Frank DeStefano reported the following:

The road department is currently collecting brush and leaves.

Monthly road sweeping for stormwater management will be completed by May 28.

Road Supervisor Nimohay received the prints for West Avenue and Summer Road and will review them for necessary adjustments. The inspected basins on Buena Drive are operational, and the engineer has been notified. Potholes are being filled.

#### **UNFINISHED BUSINESS:**

Mayor Baruffi provided an update on Minotola Estates located on Buena Drive. Mayor Baruffi stated that he spoke with Land Use Solicitor Malinsky, and Engineer DeBlasio has authorized Solicitor Malinsky to proceed with the installation of street lighting. Once the lights are installed, repaying will follow. Mayor Baruffi noted that certain issues related to trees are currently being addressed.

# A RESOLUTION APPROVING AND ENACTING A DIGITAL SIGN, FLAG, AND WEBSITE POLICY AND ESTABLISHING A REVIEW COMMITTEE TO EVALUATE AND DECIDE ON RELATED REQUESTS

WHEREAS, the Borough of Buena ("Borough") desires to embrace modern communication methods—specifically the use of municipal digital signs—while preserving community character and ensuring consistent, dignified display of all flags at Borough-owned facilities; and

WHEREAS, a comprehensive *Digital Sign and Flag Policy* (the "Policy"), attached hereto and made a part hereof, has been drafted to set uniform standards for content, scheduling, and flag protocols in accordance with applicable federal and state laws; and

WHEREAS, establishing an internal review committee will promote transparency, timely decision-making, and compliance with the Policy; and

WHEREAS, N.J.S.A. 40A:60-1 et seq. authorizes the governing body to adopt resolutions necessary and proper for the good government of the municipality.

# NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Buena, County of Atlantic, State of New Jersey, as follows:

# 1. Policy Adoption

The *Digital Sign, Flag and Website Policy* attached hereto is hereby approved and enacted in its entirety, effective immediately upon passage of this resolution.

#### 2. Creation of the Digital Sign, Flag and Website Approval Committee

- a. There is hereby established a Digital Sign, Flag and Website Review Committee ("Committee").
- b. The Committee shall consist of three (3) members:
  - I. The Mayor (or the Mayors' designee);
  - II. The President of Council; and
  - III. The Borough Administrator
- c. The Committee shall:
  - I. Review and approve or deny all request for messages to be displayed on any Borough-owned digital sign(s);
  - II. Review and approve or deny all requests to display commemorative, organizational, or special-purpose flags on Borough property;
  - III. Ensure every approved request complies with the Policy and all applicable laws;
  - IV. Maintain written records of applications, decisions, and scheduling; and
  - V. Recommend future amendments to the Policy, as needed, to the Mayor and Council.

#### 3. Administrative Implementation

The Borough Administrator is authorized and directed to publish the Policy on the Borough website, notify all departments of its provisions, and provide application forms and instructions to the public.

4. Repealer

All prior resolutions or parts thereof that are inconsistent with the provisions of this Resolution are hereby repealed to the extent of such inconsistency.

5. Effective Date

This Resolution shall take effect immediately upon adoption.

WHEREAS, Nicole Koch is qualified and capable of performing the duties of the Deputy Clerk in such instances; and

**WHEREAS**, the Mayor and Council of the Borough of Buena desire to formally designate Nicole Koch to assume the responsibilities of the Deputy Clerk during the absence, as defined below, of Pamela Johnston, and to compensate her accordingly.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Buena, County of Atlantic, State of New Jersey, as follows:

- 1. Assignment: Nicole Koch is hereby designated to serve in the capacity of Deputy Clerk during the absence of Pamela Johnston, whose current term expires on December 31, 2025, in accordance with N.J.S.A. 40A:9-135.
- 2. Compensation: Nicole Koch shall receive additional compensation in the amount of one dollar (\$1.00) per hour in the absence, defined below, of the Deputy Clerk.
